Legal Basis:

We rely on **your consent** under Article 6(1)(a) of the GDPR to process your personal data for marketing purposes. You can withdraw your consent at any time by clicking the "unsubscribe" link in any of our emails or by contacting us directly.

4. Data Storage and Security

We store your data securely using email octopus, a third part software which complies with GDPR and uses industry-standard security measures.

We take appropriate technical and organizational measures to protect your personal data against unauthorized access, alteration, disclosure, or destruction.

5. Data Retention

We will retain your email address for as long as you remain subscribed to our mailing list. If you unsubscribe or withdraw your consent, we will remove your email address from our mailing list within 30 days.

6. Your Rights Under the GDPR

You have the following rights:

- **Right to access** – You can request a copy of the personal data we hold about you.
- **Right to rectification** – You can ask us to correct inaccurate or incomplete data.
- **Right to erasure** – You can request that we delete your data.
- **Right to restrict processing** – You can ask us to limit how we use your data.
- **Right to data portability** – You can request a copy of your data in a structured, machine-readable format.
- **Right to object** – You can object to our processing of your data for direct marketing purposes.
